## RESIDENTIAL WINDOW AND DOOR REBATE Program Participation Guidelines

### HOMES THAT QUALIFY FOR A REBATE

- Existing Site-Built and Manufactured homes are both eligible.
- Homes *must* be occupied year-round; seasonal homes and homes with part-time occupancy are *not* eligible.
- Rebate(s) are for replacement windows *only* and do not cover enlargement of existing windows. Windows not inside the electrically heated area of the home, such as garages or workshops, are *not* eligible for rebate(s).
- Existing windows *must* be single pane (any frame type) with or without storms or double pane with metal frames only to qualify. Existing double pane wood or vinyl frame windows do *not* qualify for rebate(s).
- Replacement windows **MUST** have a U-Factor of .30 or lower to qualify.
- ENERGY STAR qualified door *must* be pre-hung, include replacement of the threshold and replace an un-insulated exterior door. Exterior doors *must* separate heated and un-heated space.

### REBATE AMOUNT

- Up to \$6.00 per square foot for U-Factor windows of 0.30 or lower
- Up to \$8.00 per square foot for U-Factor windows of 0.22 or lower
- \$40.00 each for qualified ENERGY STAR (or qualified U-Factor value) rated pre-hung insulated exterior door
- **Windows with a U-Factor greater than 0.30 DO NOT QUALIFY FOR A REBATE**  
*\* Rebate(s) will not exceed 100% of the installed cost*

### INSTALLER REQUIREMENTS

- Installation is not required to be completed by a contractor.

### BEFORE INSTALLATION: PRE-APPROVAL

- An on-site visit is *not* required prior to installation to qualify for the rebate, however if installation is not being performed by a licensed contractor, pre-installation photos are required.
- Rebate Applications must be submitted within six (6) months of purchase/installation to qualify.

### AFTER INSTALLATION: FINAL DOCUMENTATION

- You or your contractor must submit a completed Window and Door Rebate Application and "paid" invoice for both the purchase of the windows as well as the installation if applicable. Invoice must be dated and include the measurements for each window.
- If a registered OCCB contractor installs the windows/doors, they must provide reports documenting pre and post project conditions, including type of windows being replaced and total square footage being replaced.
- Original NFRC sticker for *every* window showing the U-Factor rating for the window.
- If project is not completed by a licensed contractor, pre and post photographs are also required.
- **All required documentation must be included with application for rebate to be paid.**

### QUALITY ASSURANCE INSPECTION

- Coos-Curry Electric reserves the right to inspect installed product(s).

### REBATE PAYMENTS

- Please allow 6-8 weeks for payment after receipt of all required documentation.
- All rebates will be paid in the form of a credit to an active CCEC member account.
- Please ensure to specify the correct account number in your application to where credit should be applied.
